#### **MINUTES**

The ARPEA Executive Council meeting began with lunch at noon. Ms. Donna Zornes was thanked for providing lunch and appreciation was expressed to AEA for allowing us to meet in their conference room.

The meeting was called to order at 12:15 p.m. by Dr. Johnnie Roebuck, Chair.

## INTRODUCTION

Ms. Zornes introduced and the Council welcomed Ms. Teri Dorrough as the new ADE EDL Program Liaison. Ms. Dorrough is a former principal at Beebe and Cabot and has taught in Pigeon Forge, Tennessee and Virginia. She holds a BA in Elementary Education and a M.Ed. in Supervision and Administration from East Tennessee State University in Johnson City, Tennessee.

## **UPDATE FROM ADE**

of products:

Ms. Zornes gave an update concerning the NASDTEC Southern Region meeting she attended as the Director of the Southern Region in Memphis February 24-26. The southern region includes Texas, Louisiana Mississippi, Georgia, Alabama, South Carolina, Florida and Arkansas. There were three people from SREB at the meeting. Ms. Zornes presented an overview of the changes in the Arkansas administrator preparation programs "From Buses, Budgets and Buildings to Learning Leaders" which was produced in collaboration with Dr. Roebuck. She felt the response and questions from the attendees were very positive.

Ms. Zornes discussed the plan for updating the ISLLC standards for school leaders which were developed in 1996. She distributed a report from Joe Simpson, Executive Director of the Interstate Consortium on School Leadership which outlines the goal of maintaining continuity with state policies while updating the standards. States will be attending on-site meetings and participating in web-based writing groups, sharing information and feedback as a community of learners. "Balanced Leadership" an article by \_\_\_\_\_\_ which outlines the 21 tasks of a leader will be the centerpiece of this update. Ms. Zornes invited the coordinators to work closely with her and Ms. Dorrough on this work. There will be five types

Updates of the ISLLC standards language and format
Defining of performance standards for initial licensure and test specification
Defining of professional level performance standards for renewal of license and test specification
Defining of advanced or mentor level performance standards

Defining of performance rubrics for a leadership portfolio

There is already a new name for the group – ICSL: Interstate Council of School Leaders will replace the name: ISLLC.

Ms. Zornes also distributed the Agreement for Uniform School Counselor Licensure Programs in Arkansas which was signed by university coordinators on October 19, 2005.

The minutes of December 14 were approved with motion by Dr. Holifield and second by Dr. Gunter.

The financial report was given by Dr. Holt and approved with motion by Dr. Klotz and second by Dr. Booth. Dr. Holt also provided a listing of 31 2005-06 members of ARPEA:

It was announced that there are no student members even though student membership fees have been set.

The Educational Administration Directory was distributed but not every coordinator received a copy. It was decided that we will try and secure more copies.

# REPORTS

Dr. Mitch Holifield introduced Ms. Beverly Williams, Assistant ADE Commissioner, who gave an update on the HB 2438 Task Force work. Ms. Williams praised Dr. Holifield's candor, which has been critical in pushing the work forward. The group has proposed to keep P-4 as is but tweak existing 5-6 so P-4 can be licensed. The recommendation is also to allow 7-12 person to become endorsed in 5-6 content only. For non-traditional program, it is recommended that entry gpa be 2.5 or 2.75 on last 60 hours. These changes will be considered at the ADE Board meeting in April. She also gave an update on the Texas A & M – Texarkana proposal for an Arkansas approved building level licensure program. She stated that she had met with representatives from TAMT and assured them that their proposal would not be considered for approval since Texas is not an NCATE state.

Dr. Keith Williams gave an update on the ARPEA Spring Conference to be held at Harding University on Monday, April 10 beginning with coffee at 9:00 a.m. Dr. Kieth Williams announced that Ms. Estelle Mathis will be the keynote speaker and will provide an overview of the scholastic audit process. There will be a panel discussion with representation from professional organizations and/or legislature. Coordinators are to submit questions for the panel who will discuss "Education in Arkansas after Lakeview." The afternoon session will be three (3) student research papers which will be chosen from submissions from all programs. Dr. Williams also asked coordinators to provide him with names of students who would present research papers at the conference. He announced the registration fee is \$40 for members.

Dr. Roebuck announced that she has still not received the SREB Rubric forms from all institutions and encouraged everyone to submit as soon as possible.

Dr. Holt discussed the progress of the Research and Advocacy Network led by Les Carmine. The pilot survey is ready.

Dr. Holt gave a report on his attendance at the NCPEA affiliate training meeting at the NCPEA conference held in San Diego February 24 - 25. This training was held in conjunction with the AASA Conference.

Dr. Booth discussed his attendance at the SREB Curriculum Module Training Session in Atlanta and said the modules mirror our performance based work with the ISLLC standards very closely but do not contain the depth or rigor of the Arkansas EDL programs. There are 14 modules with 40-50 people delivering training. Emphasis is using data to lead change.

## **OLD BUSINESS**

Dr. Williams reported on the professional development credit for EDL courses and requested that all coordinators submit their courses to him. ASU and HSU have submitted.

It was decided that the PowerPoint presentation that Ms. Zornes presented at the Memphis meeting would be available on the ARPEA website along with the PowerPoint developed by Dr. Roebuck. Coordinators may want to use these presentations as they are discussing changes and progress in our EDL programs of study.

## **NEW BUSINESS**

## PROGRAM UPDATES

**UCA** - The new dean is Dr. Larry Robinson. The EDL program is moving back to the School of Education and the new chair is Dr. Terry James.

**UAF** - approval for two new positions and 10-12 applications have been received. Applicants must be from one of the top 54 U.S. research institutions.

**ATU** - one position approved which is a carryover from last year. Successful candidate should have experience as principal with expertise in curriculum. Another request for a second position with superintendent experience is in process. Dr. Gunter announced the ASCD conference will feature Doug Reeves. There will be a 50% discount for student registration.

**ASU** - one position with superintendent experience required. Successful candidate will work with EDS and MSE programs and possibly the Ed.D.

**Harding** – one position for statistics/research. The Bentonville Center will begin offering a P-20 Ed.D. in educational leadership in August 2006 after approved by HLC.

**UALR** - one position to teach research and superintendent background preferred. EDL program is being restructured.

**SAU** - Announced that the program of study for the district level administrator numbers are down and program may be discontinued.

**HSU** - one position for someone with background in research and finance. Superintendency or central office experience required. Currently interviewing top 3 candidates.

Dr. Kieth Williams will facilitate the overall proposal offering to ADE after each institution submits their proposal to him. The proposals will need to be separated by teacher professional development offerings and administrator professional development offerings. Deadline for submission to Dr. Williams is April 24.

Ms. Beverly Williams indicated that she and her staff would review all materials and make a final decision as to appropriateness of professional development offerings.

## MEMO to Dr. Ken James Attached

Dr. Roebuck presented a memo to be submitted to Dr. Ken James and Ms. Linda Beene addressing the Texas A & M – Texarkana initiative for approval to provide administrative licensure to Arkansas students. Concerns expressed included:

No NCATE accreditation or standards from that institution

No commonality in program content

No integration of program with other Arkansas institutions

The memo will be held until all committee members have had opportunity to review and notify Deans of concern. Then memo will be submitted as signed by all ARPEA committee members and participating institutions.

## Discussion regarding Association with AAEA

In original discussion of the ARPEA Executive Committee, possible affiliation with the Arkansas Association of Educational Administrators was cited as a priority issue to encourage further collaboration among higher education institutions and practitioner organizations.

The meeting was called to order and conducted by Dr. Keith Williams in the absence of Dr. Jack Klotz. Guests and members held a working meeting over dinner at the Wyndam Hotel and Conference Center in North Little Rock, AR on July 24, 2006, at 7:00 p.m.

#### SREB

Dr. Roebuck presented concerns and facilitated discussion regarding the Southern Regional Educational Board's push for reform of educational leadership programs across the nation and apparent lack of understanding concerning the Arkansas intensive reform efforts since 2000. Issues discussed included: inclusion in a report addressing inadequacies of preparation programs and the internship experiences provided by said programs, Specific Arkansas institutions mentioned, yet little or no precise information elicited from the majority of the AR institutions/programs, impact on AR legislation and AR legislators from SREB, and need for continued voice for AR higher education institutions and preparation programs. Consensus was that continued and increased presence is a high need.

New Business:

Session One: A Response to the Issues of Licensure

This item was a response to the ADE meeting held in Little Rock, AR on November 29, 2006 for all university Deans, Department Chairs and Ed Leadership Program

Directors/Coordinators at which a notebook of proposed new administrative licensure

application forms and related existing state regulations were presented.

University Role in Licensure

Non-University Licensure Requirements: ARPEA members expressed concern about the need for the university's to collect and "validate" documents required for the licensure application that were outside the scope of the university's responsibility in licensure, such as applicant employment service records. Universities should only have to validate that a student complete an approved degree/plan of study. A request was made to eliminate the non-university items on the licensure application, including employment services records.

Official University Licensure Designee: ARPEA members expressed concern about the requirement for multiple signatures by university officials when each university has different designated persons who have this internal responsibility and Ed Leadership program directors are not always the official university designee or the repository for official university records. A request was made to make a single signature line that was generic enough to accommodate the university's official designee for licensure issues.

Student Awareness of Licensure Requirements: ADE members expressed concern that licensure applicants were not aware of licensure requirements causing problems for the department. Ken Booth suggested that this information be consolidated with the licensure forms. The group agreed that a consolidated form informing program enrollees of licensures requirements would be developed by ADE and a working group of members and an ADE representative would develop a draft in the evening working session.

Session Two: <u>Issue of Out-of-State Reciprocity</u> (Discussion and Development of as Possible ARPEA

Position Statement for Presentation to the PDLAB in January, 2007).

Discussion took place concerning issues associated with the licensing of people who hold

out-of-state administrator licenses, especially concerning the rigor of out-of-state programs, on-line programs, etc. ARPEA members wanted to know how many out-of-state people were applying for in-state licenses, whether they were initial or experienced administrators, and what states have reciprocity with Arkansas. Clarification was sought concerning the definition "regional university", which was interpreted by ADE the members of Central Association.

Donna Zornes of ADE indicated that ADE has not signed an agreement with Texas A&M to directly credential graduates of their program, but ADE did sign both the teacher and administrator interstate agreement. The group was told that other states were considering not signing this agreement in the future and that "a starting point would be to void the administrator agreement." She indicated that the criteria used by ADE to examine out-of-state licensure was 1) program of study, 2)accreditation of the institution, 3) assessment score, 4) portfolio, and 5) internship. It was indicated that PNLAB could ask ADE to revoke the reciprocity agreement.

It was resolved that a group would work this evening to determine what data to obtain and a possible resolution.

December 12 Call to Order:

Dr. Jack Klotz, Chair called the general session to order at 8:50 a.m.

Session 1& 2 (continued)

Jack Klotz asked for reports from the prior evening's two working groups.

## Working Session Report 1-Licensure Applicant Form Revisions

Terri Dorrough presented a draft of one of the proposed "Administrator Licensure Requirements" form discussion. It was agreed that the section that states "to the University Educational Administration Chairperson" would be <u>deleted</u> and that "degree" would be <u>added</u> to "Completion of the Program of Study" on the form (see attached form). Revisions of the applications based on the group's earlier requests were not submitted, but it was agreed by ADE that all mention of university responsibility for collected employment records and the like would be deleted from these forms as well. Ms. Dorrough indicated that she would send copies of all of the proposed revised applications and the licensure requirements form in the spring to Jack Klotz for distribution and comment by the membership

## Work Session Report 2-Reciprocity

Donna Zornes of ADE distributed a copy of the "NASDTEC Interstate Agreement Facilitating Mobility of Educational Personnel". The agreement permits states to add additional requirements for licensure, which "in Arkansas is not being enforced". This is the role of the ADE professional licensure division. She also stated that "the majority of states did not sign the agreement for administrators." She indicated that she could write a letter to rescind the agreement. She proposed two options 1) to try and get compliance by ADE or 2) to rescind the agreement. Concern was expressed by several ARPEA members that the group needed data concerning the number of out-of-state persons seeking initial administrator licensure versus those out-of-staters who were experienced, as well as states that had denied Arkansas administrator's reciprocity before a factual proposal could be developed.

It was resolved that Mary Gunther would develop a proposal to address the issue of initial administrator licensure for out-of-staters versus licensure for experienced out-of-state administrators. Mary would also contact Beverly Williams to set a meeting concerning the matter.

Session 3 Program Information

## **Internship Topics**

Mitch Holifield re-stated a concern expressed earlier about the interpretation from ADE that a separate internship was needed for each licensure when two licenses were being

sought. He has asked for a ruling by NCATE on the matter of a "blended" internship. Others indicated that a "dual" (two internships taken consecutively) was a way to handle both.

## **Licensure Examination Topics**

Raising the "cut" score on the SLLA for Arkansas licensees was discussed as well as the acceptability of various response patterns by ETS scorers (e.g. bulleting, holistic scoring, etc). It was suggested that changes in the passing score be postponed until the new ELCC standards were made and corresponding revisions were made in the test.

Arkansas ASCD Conference: The Arkansas ASCD conference will be in Hot Springs, AR on June 24-27, 2007. Students get 50% reduction in conference tuition if they have a letter verifying that they are enrolled in a specific class during the June summer session. There is also a \$1000 Leadership Grant opportunity and a scholarship for a person enrolled in a Curriculum Administrator program.

ASCD Advocacy Conference; There is an ASCD Drive-In Advocacy Conference in Cabot, AR concerning the re-authorization of NCLB and How to be an Advocate on January 29<sup>th</sup>, 2007. See the ASCD website for conference particulars.

<u>Curriculum Framework Revisions</u>: There will be a January conference for district and high education people concerning the approved, amended math and language arts curricula for grades 9-12 in January, 2007. See the ASCD web page for particulars.
