- Most of the meeting was dedicated to discussing the licensure board as established by Act 1811 of 2003, House Bill 2534, which has become law. The group decided to nominate Mary Gunter, Mitch Holifield, and Johnnie Roebuck to the State Board of Education, who will decide the membership of the licensure board. Letters asking for nominations will be coming from the Department soon. Mitch Holifield will respond on behalf of the ARPEA.
- 2. Mary Gunter volunteered to construct letterhead stationary to be utilized by the ARPEA Executive Council.
- 3. Jack Koltz volunteered to ask Bobby Altom to begin constructing the ARPEA website.
- 4. Mitch Holifield announced that the Southern Regional Council on Educational Administration will hold their annual conference in Little Rock in October. UALR is this year's host and is asking that their sister institutions in the state consider donating perhaps up to \$200.00 to defray expenses of hosting the conference. Kristi Pugh will be contacting Honor in an attempt to establish a preconference session to discuss with Arkansan professors of ed admin/leadership the new ELCC standards. - 5. The council decided that the first general meeting of ARPEA will be held spring 2004. Jack Koltz, Carleton Holt, and John Jones will be subcommittee that will plan the conference.
- 6. Pat Bashaw was congratulated on becoming Director of Graduate Studies at Harding University.
- 7. Kristi Pugh announced that all the forms for licensure application are now on the Department's website.
